

**LOS ANGELES GALAXY AUTOGRAPHED SOCCER BALL  
SWEEPSTAKES  
OFFICIAL RULES**

**ELIGIBILITY: NO PURCHASE NECESSARY TO ENTER OR WIN. LOS ANGELES GALAXY AUTOGRAPHED SOCCER BALL** Sweepstakes (the "Sweepstakes") is open to legal residents of the United States (except Puerto Rico, Guam, U.S. Virgin Islands, and all other U.S. and foreign territories and possessions, and excluding where otherwise prohibited by law, rule or regulation), who are of legal age of majority in the jurisdiction in which they reside (and at least 18 years) at the time of entry. Employees, officers, and directors (including immediate family members (spouse, parent, child and sibling and their respective spouses, regardless of they reside) and members of the same household, whether or not related) of Anschutz L.A. **1. By submitting your completed online entry form as directed, you will be automatically entered in the Sweepstakes. Entrants must complete all non-optional data requested on the online entry form. Incomplete entries are void.

**2. Mail-in Method:** If you do not wish to enter online, you may enter the Sweepstakes by hand-printing your name, address, city, state and zip code, day & evening telephone number (including area code), date of birth and e-mail address (optional) on a standard size postcard and mail to: Los Angeles Galaxy Autographed Soccer Ball Sweepstakes c/o Marketing Coordinator, 714 West Olympic Blvd., Suite 400, Los Angeles, CA 90015. Sponsor will only use e-mail addresses provided via the Mail-in entry method for prize notification purposes only; however, eligibility to participate in the Sweepstakes is not dependent upon entrant's provision of this information. **PRIZE: One (1) Prize Will Be Awarded.** Winner will receive a Los Angeles Galaxy soccer ball autographed by one or more members of the Los Angeles Galaxy as determined by Sponsor in its discretion and based on availability (the "Prize"). (Estimated Retail Value of Prize: US\$20.00). The Winner is fully responsible for any and all applicable federal, state, and local taxes (including income and withholding taxes). All costs and expenses associated with Prize acceptance and use not specified herein as being provided, including but not limited to lodging, transportation costs, meals, taxes (including income taxes) and gratuities and other expenses incurred by accepting the Prize are the sole responsibility of the Winner.
